The above numbered and described solicitation is amended and set forth below:

Section I. PURPOSE OF SOLICITATION

The Department of Integrated Services for Individuals with Disabilities (DISID) is soliciting proposals from non-profit and for profit organizations qualified to provide professional Adult Day Care Services for individuals with severe disabilities.

Contractor – Subawardee/Subrecipient will provide compliant management and operations of Adult Day Care Services to approximately 20 individuals age 18 to 59, on every service day, who have been determined to be functionally impaired and are at risk of institutionalization, and to provide respite services for families/caregivers of these individuals while the individual is attending the Adult Day Care Center.

TYPE OF SERVICES. Offerors are required to provide compliant Adult Day Care (ADC) services which includes:

Individuals with disabilities will be in a supervised, protective, and congregate setting during some portion of a day. Services offered in conjunction with adult day care typically include social and recreational activities and training in activities of daily living skills.

The Department of Integrated Services for Individuals with Disabilities (DISID) is soliciting proposals from non-profit and for profit organizations qualified to provide professional Adult Day Care Services for individuals with severe disabilities.

The services requested will be federally funded through DISID's American Rescue Plan Act (ARPA) funding. Pursuant to ARPA Interim Final Rule at 76 Fed.Regis 26786 (May 17, 2021) and Final Rule at 31 CFR Part 35 (April 1, 2022), eligible usage of funds includes "services or outreach to promote access to physical or behavioral health primary care and preventative medicine." 76 Fed.Regis 26791.

Contractor – Subawardee/Subrecipient will provide compliant management and operations of Adult Day Care Services to approximately 20 individuals age 18 to 59, on every service day, who have been determined to be functionally impaired and are at risk of institutionalization, and to provide respite services for families/caregivers of these individuals while the individual is attending the Adult Day Care Center.

TYPE OF SERVICES. Offerors are required to provide compliant Adult Day Care (ADC) services which includes:
